Road Traffic Changes

Lebanon Road has long had a reputation as a rat-run because it was used as a cut through from Addiscombe Road to Lower Addiscombe Road. On 7th July 2015 Croydon Council's Traffic Management Advisory Committee voted to make Lebanon Road a NO ENTRY road. Our own ward councilor – Mark Watson – who lives on Lebanon Road played a key role in lobbying and agitating for the change. Lebanon Road was closed in January 2016.

Unsurprisingly the traffic has simply moved to the next through road – Addiscombe Court Road – our road. Previously it would be surprising to find more than a handful of cars travelling northbound down the road, now there are **in excess of 1400 vehicles per day** – a tripling of northbound traffic. However, the Council's impact assessment did not consider the obvious possibility that the traffic would simply be displaced into the next adjacent through road – Addiscombe Court Road. Nor were residents in Addiscombe Court Road consulted – which is a legal requirement. And Croydon knew our road would be impacted – they put traffic monitoring devices on our street!

No Consultation

The council chose to only consult with roads nearer to East Croydon, which would not be affected, as they are NOT through roads. They chose not to consult out road. So the Council decided to simply route a huge traffic problem from one street, to an even narrower street - our street - without consulting you! Additionally the Committee was told all the surrounding streets were one way - but the top half of Addiscombe Court Road is not! Whether this was simply incompetence or for other reasons is unknown.

Why weren't residents on Addiscombe Court Road consulted when changes to the road scheme has a direct impact on residents? Especially when Croydon knew that our street would be impacted – they actually put in place monitoring devices on Addiscombe Court Road to measure it.

- · Parents access to the school in Tunstall Road
